Important Details and Instruction :

1. The Bidders are requested to make themselves fully conversant with the scope of work seeing working site, technical specification, general terms and conditions as per the work contract for **RSETI BALLIA**, special terms and conditions etc. before submission of the tender and thereafter they should quote their rates in price schedule accordingly so that no ambiguity at later stage arise.

2. The bidders are requested to Visit the Site for Actual measurement of working site.
3. The tender must be submitted in **two parts**, known as part-I (pre-qualifications for opening of Part-II) and **part-II (price bid)**. Part-I of the tender shall be opened OFFLINE MODE in the presence of bidder's representatives, who choose to attend at the prescribed venue, date and time mentioned in tender notice. Part-II of the tender shall be opened after the approval given by committee, of only those bidders who have fulfilled the pre-qualifying conditions of the tender on the basis of documents submitted in Part-I of the tender. Opening date of the Part- II shall be informed later. Time of opening of part-II will remain same as of part-I. Part-II of the tender shall be opened offline mode in the presence of bidder's representatives, who choose to attend at the prescribed venue, date and time.
4. Technical and Financial bid must be submitted by the bidders at Regional office Deoria **not later** than prescribed date and time as in tender notice.
5. **Two Bid System.**
 - a. **Envelope marked no 1** shall contain DD of tender cost duly signed photocopy of MSME registration certificate, duly signed tender papers, technical bid, GST no., TIN no., PAN, address proof. Copy of work orders, completion certificates of similar type of works and all **documentary evidence fulfilling eligibility criteria** and other required documents. This envelope shall be endorsed on the outside face "Technical bid and sealed properly.
 - b. **Envelope marked no. 2.** Shall contain the Price bid. This envelope shall be endorsed on the outside face "Price bid and sealed properly.
 - c. **Envelope no. 3.** Envelope marked no. 1&2 shall be put in a envelope marked no 3 which shall be properly sealed. This envelope, which shall be endorsed on the outside face. "**Construction of Pre Cast Boundary wall at RSETI BALLIA under BALLIA District** " and addressed "Regional Head DEORIA, Central Bank of India, Regional Office, DEORIA
6. The purchaser may at his discretion, extends this deadline for submission of bids by amending the bid documents.
7. **Late Bids**
Once the bid submission period is over, the bidder cannot submit their bid. Bidder has to start the bid submission well in advance so that submission process is completed within the scheduled period. Failing which it shall be the Bidder's responsibility.
8. **Withdrawal and resubmission of bids**
 - A. A Bidder may withdraw their bid submitted offline at point of time before the bid completion of bid submission period.
 - B. The Bidder has to request the Purchaser with a letter, attaching the proof of withdrawal and submission of bid Security/ EMD in the office of purchaser for taking back the bid security/ EMD as per the manual procedure.
 - C. The Bidder can resubmit their bid as and when required till the scheduled bid submission end date and time. The bid submitted earlier will be replaced by the new one. The bid security submitted by the bidder earlier will be used of revised bid and

the new bid submission summary generated after the successful submission of the revised bid will be considered for evaluation purpose.

- D. The bidder can submit their revised bids as many times as possible by submission their bid

documents within the schedule period for submission of bids.

9. Bidders are advised to study the bid document carefully. Submission of bids against the tender notice shall be deemed to have been done after careful study and examination of the working site, procedure, terms and conditions stipulated in the bid documents with full understanding of its implications.
10. All bids must be accompanied by bid Earnest Money & Tender Fees deposited through Demand draft in favour of "Central Bank of India Payable at Deoria" within the schedule time. Failing which the bid shall not be considered/opened & is liable to be rejected.
11. The bids shall be opened offline mode in the presence of bidder's representatives, who choose to attend, at the prescribed venue, date and time mentioned above.

PRE QUALIFYING CONDITION OF TENDER

1. All bids must be accompanied by bid Earnest Money & Tender Fees deposited through Demand draft in favour of " Central Bank of India Payable at Deoria" within the schedule time. (**MSME registered firms will be exempted from submission of Earnest Money & Tender fee, if applicable**)

2. The bidder should submit latest income Tax Clearance certificate / return file and PAN no.

3. The bidder Should submit a copy of VALID and relevant Scale GST registration certificate, having also GSTR3-B of Last 06- Months.

4. Labour license as per Rule. In case no Labour license exemption for the same certified by labour department.

5. Latest turnover of the firm issued by the Bank /CA/Audited balance sheet. Average annual financial turnover during the Last 03 year, ending 31st March, should be at least 30% of the estimated cost.

6. Copy of LOI/Agreement/ Experience certificate of similar nature works Government / semi Government Department, which shall be :-

- Three similar nature works completed & costing not less than the amount equal to 30% Each of the estimated cost.
- Two similar nature works completed & costing not less than the amount equal to 40% of each of the estimated cost.
- One similar nature works completed & costing not less than the amount equal to 60% of each of the estimated cost.

7. A copy of Partnership deed in case Tenderer's is partnership firm. In case of limited company, a copy of registration certificate issued by Registrar of Companies.

9. EPF registration certificate duly issued by EPF office shall be submitted by the tenderer.

SPECIAL CONDITIONS OF THE CONTRACT

These special conditions of the contract shall be read and construed along with the annexed general conditions of contract form "A" (modified by the provision here of) but if, there is any conflict or inconsistency between the provision hereof and those contained in general condition, the special conditions shall prevail.

1. SCOPE OF WORK :-

The scope of work involved, will be as per schedule of rates & quantity and technical specification as enclosed.

2. TIME FOR COMPLETION:-

The work covered under scope of work shall be completed within time as schedule in tender notice.

3. DATE OF START OF WORK:

The date of start of work under this contract shall be intimated .

4. LEVY OF PENALTY:-

A penalty @ ½% per week subjected to maximum of 10% of total value of the contract for delay in works beyond the time of completion shall be levied.

5. ACCIDENT/ DEATH OF WORKER:-

The contractor shall be responsible for payment of accidental benefit and compensation in case of death of any worker engaged by him, as per provision of rules/ order of the govt. under the compensation act, No liability whatsoever will be acceptable by the Central Bank of India. The contractor shall be fully responsible for any sort of accident or injury to the labour while on duty and he will take all possible measures to ensure that no such event is occurred. In case of any accident of any nature, during the execution of the above work, the department will not be held responsible or liable to make any compensation to contractor's labour.

2. TERMINATION OF THE CONTRACT :-

On 15 days notice the contract can be terminated without given any further notice. Also the contract can be terminated at any time in case it is found that the work is not being carried out to the satisfaction of the engineer-in-charge or the satisfaction of his representative. Under such condition, the complete work will be got done through other agency and all such extra expenditure incurred will be debited to the contractor's account.

3. TRANSPORTATION OF MEN & MATERIAL:-

Contractor will make his own arrangement for the transportation of his men and material to work sites and back. Site storage facility will be provided to the contractor free of cost if available.

4. INCOME TAX :-

- (a) Income tax, labour cess etc. & other taxes shall be deducted from the bill as per rule.
- (b) GST will be paid extra as per rule.

5. TERMS OF PAYMENT:-

- (a) 90% payment shall be released against running bill of the contractor .
- (b) Balance 10% payment shall be released after expire of 12 months from date of completion, guarantee period OR 100% payment shall be released on submitting FDR/CDR of balance 10%.

6. VARIATION IN QUANTITY OF WORK:-

The quantities contained in schedule of bids are approximate and change up to any extent due to change in design, site requirement / complaints or any other reason whatsoever but excess value shall be restricted +10% of agreement value.

7. RATES :-

No escalation of rates over the finally accepted rates for escalation of the work shall be allowed during the pendency of contract.

8. OTHER TERMS AND CONDITIONS:-

(a) The contractor shall remain liable to remove the defect that may develop in the works arising solely from the faulty workmanship.

(b) The In-charge shall have the right to object employment or presence of any person, labour employed by the contractor for non compliance, negligence, misconduct of being considered undesirable in the interest of work and of receipt of objection, the contractor shall be bound to remove such person from the work areas.

(c) The contractor shall not be entitled for any claim caused by removal of person(s) as aforesaid.

(d) If for some reason, the department is unable at any time to clear the site and the work has to be stopped, the contractor shall not be entitled to any monetary claim arising out of such circumstance. He shall however be granted time limit extension to the extent, for such period during which the work remained suspended.

9. All the disputes arising out of/in relation to this agreement shall be subject to the jurisdiction of the local courts of Deoria.

10. All replaced parts / scrap material arising out of work/site shall be returned to the department.

11. In case of any loss or damage to Bank's RSETI Deoria property during the execution of work due to negligence on the part of contractor's artisan / labour, the contractor has to bear the charges of these losses as assessed by the Regional Head / Chief Manager. In this regard, the decision of Regional Head / Chief Manager will be final and binding on the part of contractor.

12. The contractor will observe all the rules and regulations of Factories Act, Workman Compensation Act. etc.

13.. If work allotted /awarded, a affidavit on stamp paper of Rs. 10.00 is to be submitted for exemption of stamp duty.

14. The Contractor or his authorized representative will keep close liason with the concerned In-charge for taking day to day instructions regarding maintenance work or otherwise.

15. All materials used at the site in above tender should be get approved by In-charge of the work before taking in to use.

16. Water supply required at site shall be arranged by contractor at his own cost and charges.

17.. Electric supply, if required for maintenance work shall be given by Bank at applicable rates for completion of work. Or arranged by contractor on own cost.

18. All works have to be completed strictly as per Bank Irrigation specification (as the case may be)

19.. Proper site cleaning will have to be done by the contractor at his own cost after completion of work and before handing over to the department.

20.. All quantities are tentative and may be varied as per site conditions upto any extent on either side.

21. All security arrangements for the material will be contractor responsibility. In case of theft or missing of any item double the market rate shall be recovered from contractor bills.
