Empanelment of Contractor for AMC of UPS at Branches under Regional Office, Shimla on Rate Contract Basis.

1. Objective: - Central Bank of India, Regional Office Shimla having a network of **58/01 Branches/Regional Office** spanning within States/Districts (Attached List of Branches/Offices) invites sealed/tenders from eligible agencies for empanelment on a Rate Contract Basis for annual maintenance contract of UPS in all branches including Regional Office Shimla under our jurisdiction. The contract shall remain valid for minimum 01 year (extendable by one year on satisfactory performance).

The Bank reserves the right to increase or decrease the number of branches and quantities without assigning any reason.

2. Area of Operation: - The contractor shall undertake work at all existing and future branches/offices under Regional Office Shimla as per attached.

3. RFQ (Request for Quotation)

The quoted rates shall be firm and fixed during the contract period. Rates shall include Material, Labour, Transportation, Installation, Loading/Unloading, all taxes **except GST**, no escalation shall be allowed.

4. Completion Time: - Each complaint from branch shall be resolve within 01-02 days from the date of complaint lodged.

5. Payment: - Payment shall be released as per satisfactory work done on quarterly basis after receiving visit report of Engineer/Technician.

6. Eligibility: - GST Registration, PAN, ITR, experience in similar works, Experience with Banks/PSUs/Government organizations preferred, firm should not be blacklisted with any organization (**Central Bank of India may contact other organizations which have issued the work orders to the bidder**).

7. Terms & Conditions: -

- Payment will be done on quarterly basis after submission of reports.
- The Bank may add or delete branches during the contract period.
- The contractor shall execute work at any branch within the Region at the approved rates.
- Rates shall remain valid throughout the contract period.
- Stand by UPS will be provided until the existing UPS is repaired.
- The Bank is under no obligation to award any minimum value of work.
- The contract shall remain valid for minimum 01 year (extendable by one year on satisfactory performance).
- One Common bill will be submitted in the Regional Office for the payment.
