REG: AMRITOTSAVA REWARD FOR EX-STAFF AGED 75 YEARS & ABOVE WHO RETIRED ON SUPERANNUATION – STAFF WELFARE SCHEMES FOR FY 2025-26.
REF: STAFF CIRCULAR NO. 1757 DATED 30.06.2025.

With reference to the captioned matter, **Amritotsava Reward For Ex-Staff Aged 75 Years & Above Who Retired On Superannuation** is one of the schemes under Staff Welfare Schemes for the FY 2025-26. The objective of this scheme is to provide one-time ex-gratia payment as financial assistance to our Bank's Retirees or to their spouse who retired on superannuation and having completed 75 years of age & above as on 31.03.2026. The scheme intends to obviate their financial hardships to a certain extent looking into their increased medical expenses, health insurance premiums etc.

Amount of reward for FY 2025-26 shall be as per table below-

In view of the above, the **CENT AMRITOTSAV REWARD** to all eligible Retirees & Family Pensioners is proposed to be disbursed on **26.01.2026**, in accordance with the details provided in the above table. In this regard, the following points may please be noted –

- This scheme shall remain effective from 01.04.2025 to 31.03.2026.
- Submission of Life Certificate is mandatory for availing financial assistance under the scheme.
- The retirees who have submitted Life Certificate till 22.01.2026 will be paid on 26.01.2026.
- The reward shall be paid only to retirees who submit Life Certificate on or before 31.03.2026. No claims will be entertained after **31.03.2026**.

- (v) The eligible amount shall be directly credited to the pensioner's Central Bank of India account on a first-come, first-serve basis, subject to availability within the approved budget for the scheme.
- (vi) Ex-staff or their spouse, who retired on superannuation however are PF optees, shall submit their claim in prescribed format (Annexure-I) which should be submitted to branch or scanned copy directly to Retiral Benefits Department, Central Office on email-id smpension@centralbank.bank.in. PF optees should mandatorily mention their account number maintained with Central Bank of India for availing this benefit.

Accordingly, all concerned are requested to inform eligible pensioners and family pensioners to submit their Life Certificates within the stipulated period to avail the benefits under the scheme.
