- The Sale will be done by the undersigned through e-auction platform provided at the Website <https://BAANKNET.com>. on 15.01.2026 (12:00 Noon to 04:00 PM). The intending Bidders/Purchasers are requested to register on portal (<https://BAANKNET.com>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time.
